

## ABOUT GRADUATE STUDY

City College offers more than fifty different master's degree programs in the College of Liberal Arts and Science as well as in Architecture, Education and Engineering. Master's programs are designed both for the student seeking graduate training ending at the master's level and for those interested in preparing for admission to doctoral degree programs. Beginning in Fall 2008, the City College will offer the doctoral degree in Engineering (Biomedical, Chemical, Civil, Mechanical and Electrical Engineering) previously offered by the City University (CUNY) Graduate Center. More than eighty-five percent of students enrolled in the College's graduate programs will pursue more advanced degrees. Currently, more than six hundred master's degrees are conferred each year.

The City College's student body of approximately 15,000 men and women is drawn from eighty different countries and represents some fifty different language groups, bringing an international and cosmopolitan ambiance to the campus. The wealth of diversity and range of knowledge represented in the graduate student body is an important learning asset that enriches all student experiences. An equal number of men and women make up the graduate student body of approximately 3,000. Two-thirds of these attend school on a part-time basis.

Also in Fall 2008, The College will begin offering joint degrees in Science (Biology, Chemistry, Biochemistry and Physics) with the City University Graduate Center. As in the past, Ph.D. programs in Computer Science, Clinical Psychology, Experimental Cognition and Earth and Environment Sciences continue to be based wholly or in part at the City College campus. The graduate programs are designed for individuals at different stages of career development. Students returning to school after time spent working or in other pursuits will find a particularly receptive environment. Schedules can accommodate both full-time and part-time students.

Programs offer a balance of coursework, research training and, where appropriate, supervised fieldwork. The graduate faculty engages students in classrooms, tutorials, laboratories and independent inquiry, to develop skills in creative thinking as well as in the academic discipline.

## GRADUATE STUDIES

Applications are reviewed on a rolling basis. You are encouraged to submit a completed application at your earliest convenience to ensure that it will be reviewed by the appropriate departmental admissions committee as soon as possible.

*The Media Arts Production, Fine Arts (Studio Art), Mental Health Counseling, Public Service Management and all programs within the School of Architecture admit students only in the fall semester.*

**International students should allow at least six months to a year** for completion of the application process. To prevent delays, we encourage you to plan accordingly.

### The Self-Managed Application

I. This application packet provides forms with which applicants request official transcripts of previous academic work and letters of recommendation to be returned to them in sealed envelopes, signed by the recommender. These are then sent together with the applicant's fully completed application, application fee and personal statement in one single envelope.

II. The self managed application has the advantage of giving the applicant responsibility for the process of gathering the required supporting material and facilitating City College's processing of the application. The General Record Examination (GRE) and the Test of English as a Foreign Language (TOEFL) Score Reports must be sent directly from the Educational Testing Service (ETS). The College's ETS number is 2083.

Each department has specific procedures for evaluating admission to its program and may have additional requirements. Admission is granted jointly by the CCNY Office of Graduate Admissions and the individual graduate program.

Once the Office of Graduate Admissions has received your complete application, it will be forwarded to the appropriate admissions committee. After it is returned to the Office of Graduate Admissions, you will receive a letter indicating the committee's decision.

Basic requirements for graduate study include a baccalaureate degree (or a U.S. equivalent for international students) from an accredited institution of higher education. The Computer Science Program is open only to students with a computer science baccalaureate degree or extensive undergraduate coursework in this field of study. Contact the Computer Science department for details.

You may be asked to submit documents confirming New York State residency in order to be eligible for in-state tuition. Admitted students will receive residency forms if necessary.

Applicants should be aware that all supporting documents received by The City University of New York and The City College of New York in support of an application for admission become the property of The City College of New York and the City University of New York and will not be returned to the applicant or sent elsewhere.

All information requested on an application submitted to The City College of New York must be answered fully and correctly. Omission of colleges, universities and/or proprietary schools attended or falsification of information will constitute grounds for permanently rescinding the offer of admission, disciplinary action and/or dismissal.

A **completed application**, with student's signature, supporting documents and non-refundable application fee should be sent to the Office of Graduate Admissions, ***not to the departmental offices***. Material sent directly to departmental offices will result in the delay of application processing. Applications that have not been signed by the applicant will not be processed.

A **non-refundable application fee of \$125**, must accompany this application. Make check or money order payable to The City College. Applications received without the fee will not be processed. **Fee waivers are not available.**

**Official transcripts** from all institutions previously attended must be included with the application. Send the TRANSCRIPT REQUEST FORM to the Registrar of each college or university attended. Transcripts must arrive in the envelope, sealed and stamped by the Registrar's office. If the official transcript does not include the conferral date of baccalaureate degree, please request an official copy of the diploma or provisional certificate as well. Transcripts (and diplomas) not in English must be accompanied by a translation. See section titled GUIDELINES FOR OFFICIAL TRANSLATIONS OF DOCUMENTS for more information.

**Letters of Recommendation** – College of Liberal Arts and Science applicants must submit two letters; International Relations and Mental Health Counseling applicants must submit three letters; Engineering applicants must submit two letters. **Recommendations must be submitted with the forms attached and should be written on the professor's departmental letterhead (stationery)**. Recommendations must be academic, not personal. Please include the appropriate number of recommendation letters in your application packet. **Do not open envelope.**

A **personal statement** about your educational or career objectives should be typed and enclosed with the application. The personal statement is your way of introducing yourself to the Program Review Committee. Your personal statement should be of the kind and quality that expresses why you have chosen to pursue a graduate degree. The personal statement is one of several credentials that will determine your eligibility for admission to a graduate degree program at The City College of New York and should be no longer than one page in length.

**E-mail:** Please be certain to include your e-mail address, if available, on your application. Note: Please be aware that Yahoo, Hotmail and AOL may interpret e-mail from City College as spam. An applicant should periodically check bulk mail for correspondence from City College.

## INTERNATIONAL APPLICANTS

The TOEFL is not required of students from countries where English is the official language, or by students who have studied full-time at a university for at least two years in a country where English is the official language. The TOEFL is not required of permanent residents of the U.S. or individuals who have been granted official refugee or asylum status by the U.S. Citizenship and Immigration Service.

TOEFL score reports must come directly from the Educational Testing Service (ETS) to be official. TOEFL scores expire after two years. The Institutional Code for City College is **2083**. This Institutional Code number will ensure that TOEFL scores are sent to the City College Office of Admissions. Student copies of the TOEFL are **not accepted**. The City College of New York does not accept International English Language Testing System (IELTS) scores or the CUNY TOEFL Exam.

### Guidelines for Official Translation of Documents

International students educated in countries where English is not the official language must provide official academic transcripts and diploma in both their native language and the English language translation. The following guidelines must be followed for translations to be official. The Office of Graduate Admissions reserves the right to reject translations that do not meet these guidelines. Please see your local telephone directory for listings of translation services.

#### OFFICIAL TRANSLATIONS MUST:

- Be prepared using the same format as the original
- Be verbatim and have all information translated
- Be typed and signed by the translator

#### OFFICIAL TRANSLATIONS CAN ONLY BE PREPARED BY THE FOLLOWING:

- Consulate or embassy of the country that issues that document or translations
- Translation service or agency or immigration / refugee association
- The institution where the student received his / her degree
- A faculty member of a U.S. university

#### TRANSLATIONS BY U.S. FACULTY MEMBERS MUST:

- Be typed on school letterhead / stationery
- State that the translator is a faculty member and of which department
- Include a signed statement from the translator attesting to his / her familiarity with the foreign language

A student who has not studied in an English speaking country and who is not a permanent resident must take the Test of English of as a Foreign Language (TOEFL) administered by the Educational Testing Service. It is required those students obtain a score of 73 or higher on the new Internet Based TOEFL: (IBT) examination. For Biomedical Engineering, a TOEFL examination result of 79 is required.
